# AWARD CATEGORIES

## CATEGORY 1

### Avoid Recover Protect – Community Waste Award

*This award is open to all individuals and organisations.*

Awarded to an individual, group or organisation for excellence in avoiding or recovering waste or protecting the environment from the impacts of household and community waste, resulting in positive outcomes in the waste sector.

## CATEGORY 2

### Avoid Recover Protect – Commercial and Industrial Waste Award

*This award is open to all individuals and organisations.*

Awarded to an individual, group or organisation for excellence in avoiding or recovering waste or protecting the environment from the impacts of waste generated from commercial and industrial activities, including building and construction.

## CATEGORY 3

### Avoid Recover Protect – Waste Management Award

*This award is open to all individuals and organisations.*

Awarded to an individual, group or organisation for excellence in avoiding or recovering waste or protecting the environment through the management of waste streams generated by the community or industry.

## CATEGORY 4

### Avoid Recover Protect – WA Regional Waste Award

*This award is open to all individuals and organisations.*

Awarded to an individual, group or organisation for excellence in avoiding or recovering waste or protecting the environment from the impacts of waste in regional Western Australia, resulting in positive outcomes in the waste sector (particularly in the regions).

## CATEGORY 5

### 2021 Waste Champion

*This award is open to all individuals over 18 years of age.*

Awarded to an individual who has demonstrated outstanding commitment and contribution to better waste management.

## CATEGORY 6

### 2021 Young Waste Achiever

*This award is open to all individuals 18 years of age or younger.*

Awarded to a young individual who has demonstrated outstanding commitment and contribution to better waste management.

## CATEGORY 7

### Waste Team of the Year

*Open to any group or team of people (including business, school, community and organisational teams).*

Awarded to a dedicated team that has demonstrated outstanding commitment and contribution to better waste management.

## CATEGORY 8

### Waste Innovation of the Year

*This award is open to all individuals and organisations.*

Awarded to an initiative which has demonstrated exceptional innovation in waste management, improvement, practices and outcomes.

## CATEGORY 9

### WasteSorted School of the Year

*Open to all public, independent and non-government schools in Western Australia from K-12.*

Awarded to a school community that has demonstrated outstanding commitment and contribution better waste management.

## CATEGORY 10

### Media Award

*Open to all journalists, photographers and camerapersons based in Western Australia or working for WA-based media organisations.*

Awarded for excellence in reporting on waste issues – recognising accuracy, newsworthiness, insight, impact and public benefit.

## DISCRETIONARY AWARDS

All entrants into the 2021 WasteSorted Awards will be considered by the judges for up to two discretionary awards.

### 2021 WA Waste Award

Awarded to an individual, team or organisation for outstanding contribution to the waste industry.

### 2021 Waste Initiative of the Year

Awarded to an initiative which has demonstrated outstanding achievement in the waste industry.

---

#### DEFINITIONS:

**Organisation:** refers to any business; community group; not-for-profit organisation; local government authority; state government agency, department or unit; school or social enterprise.

**Individual:** refers to an individual person (including members of the local community, householders, or a member of an organisation).

**Initiative:** refers to a specific project, product, program, system or process implemented that has significantly changed the way things are done, or has brought about changes, or has resulted in a shift in behaviour for the general good, a business or an approach.

**Age of applicants** for Category 5 and Category 6 is determined as being under or over 18 years of age on or before 31 December 2021.

**Regional:** refers to areas of Western Australia outside of the Perth Metropolitan area, being all local government areas identified by the WA Local Government Association within Zone Map 1 and Zone Map 2

## ENTRY REQUIREMENTS

### ESSENTIAL

1. **Nomination form.** You must return a completed and signed nomination form for each entry category you are entering.
2. **The submission document.** This is your written response to the assessment criteria and is the main part of your entry that is assessed by the judges. Word limit is strictly as set out in the assessment criteria. Please structure your answers according to the assessment criteria. The use of headings, photos, graphics, tables and charts is encouraged.
3. **Images.** Please provide up to three high quality images for promotional purposes. These images should be provided as jpegs (300dpi minimum). These images do not form part of the assessment, but will be used for promotional purposes during the awards presentation, publications, and digital/social media. Please do not include your logo in these images – logos will not be accepted.

### OPTIONAL


You may submit other material and documents to support your entry and better illustrate its impact and results. Examples include reports, testimonials, media coverage, analytics, photos, videos and so forth. It is essential that all supporting documentation be referenced within your submission.

### SUBMITTING YOUR ENTRY

Completed entries must be submitted in electronic form only to [wastesortedawards@millswilson.com.au](mailto:wastesortedawards@millswilson.com.au) by **5pm (WST)** on **Tuesday, 2 February 2021**.

## THE PROCESS

1. **Entries.** Nominees complete and submit their entry, including a signed nomination form, before 5pm (WST) on Tuesday, 2 February 2021.
2. **Shortlisting.** Judges will assess the entries against the assessment criteria and prepare a shortlist for each awards category.
3. **Screening.** Shortlisted entries will be screened to confirm they comply with the eligibility criteria.
4. **Scheduling.** The primary contact person for each of the shortlisted nominees will be contacted to arrange an interview with the judging panel. Interviews will take place between Monday, 15 March and Thursday, 18 March 2021 in Perth, or via teleconference or video conference if required. A representative from the shortlisted nominees must be available for an interview during this period.
5. **Interviews.** The judges and shortlisted nominees meet to allow the judges to ask questions and gain a greater insight, and so entrants can share more information about themselves and their work.
6. **Assessment.** Following the interviews, the judges will select the finalists and winners of the 2021 WasteSorted Awards.
7. **Announcement.** The winners will be announced at the WasteSorted Awards gala dinner on Wednesday, 5 May 2021.

- Please include copies of your nominated work (which may be a single item or series).
- Highlight the key aspects about your work. Consider originality and innovation, newsworthiness, impact and incisiveness, ethical journalism, research, production skill and public benefit.
